I will notify the Troup County Health Department upon completion of construction and before applying final cover. I understand that the Troup County Health Department will not be responsible for conditions unknown at the time of permit issuance. This application expires (12) months from the date of issue.

Septic Tank Applications

1. In order to expedite the septic tank permitting process, the following information must be provided on your site plan for use by Environmental Health.
 - Subdivision (S/D) name and lot number, if not an approved subdivision, provide a plat of the property.
 - Dimensions of lot, with the exception of lots over 3 acres.
 - A sketch of the proposed house on the lot, showing dimensions and ground surface square footage of the house, including garage.
 - Location of any proposed: pools, garages, gazebos, barns, other outbuildings, etc.
 - Location of the proposed septic tank, drainfield, and drainfield reserve area. Note: These locations may have to change based on Environmental Health Site Review.
 - The driveway location, its length, width and the road from which it branches.
 - Distance from property lines and road to house.
 - Location of any proposed trash pit (NOT RECOMMENDED must be approved before any digging) NOTE: No pits allowed on 1.5 acres or less.
 - Location and distance to any lake, pond, stream or drainage ditch on the property.
 - Location and distance to any well from house, septic tank and drainfield.
2. Put the above information on the grid provided on page 3, with all measurements shown. Please follow example provided on page 2 when drawing your sketch.
3. When preparing your property for inspection please do the following:
 - Mark property with some type of sign, poaster board will be acceptable, so that we can easily ascertain the lot location and lot number, if applicable, from the road.
 - Stake the corners of the poster board structure along with the property lines with stakes that are at least two feet in height and easily visible through the use of colorful ribbons or paints. Should we not be able to find stakes on initial site inspection, your permit will be placed in holding until stakes are put in place, thus delaying issuance of the permit.
 - Ensure that any proposed future is also visibly marked such as pools, etc.
4. We may not be familiar with your property, so give directions and mark property accordingly. When giving directions, please make them as detailed as possible, giving directions from major highways, known existing landmarks and give distances up to a tenth of a mile. ANY CHANGES MADE TO THESE SUBMITTED PLANS, ONCE PERMITTED, WITHOUT PRIOR APPROVAL OF THE ENVIRONMENTAL HEALTH DEPARTMENT WILL VOID YOUR PERMIT.

Sketch Of Property

- Provide a sketch (in space above) of proposed building location, driveway, septic system, initial and reserve area locations, and all additional structures (existing and proposed).
- Show the dimensions of the lot and setback distances from the house and other structures to property lines.
- Note any wells, proposed trash pit locations, streams, ponds or lakes on property.
- The corners of the house must be clearly staked before the initial site review can be done.
- Show the Northerly Direction with a North Arrow.
